All breeding seasons sold and purchased through the OTOBA Stallion Season Auction are subject to the conditions outlined in each individual participating stallion's normal breeding contract issued by the farm standing the stallion. Mare care and veterinary fees are not included in the price of the breeding purchased through the OTOBA Stallion Season Auction.

Unless specifically stated otherwise under the terms of the participating stallion's breeding contract, you are purchasing a NO GUARANTEE SEASON for the year 2011.

In the event said stallion dies or is incapable of fulfilling breeding commitment, purchaser of season shall receive full refund of season purchase price from OTOBA.

Resulting foals from purchased seasons will be fully eligible to the year 2015 OTOBA Stallion Stake.

The owner of a mare participating in the OTOBA Stallion Season Auction hereby releases the Oregon Thoroughbred Owners & Breeders Association, Inc. and any authorized agent or employee of the OTOBA from any liability based on the OTOBA Stallion Season Auction.

A \$50 deposit payable to the OTOBA is required within 5 days of notification of your successful bid. The balance of the purchase price is due no later than Jan. 31, 2011. Seasons purchased after Oregon Champion Day shall be paid in full by February 28th, 2011. If the purchaser defaults, their deposit is forfeited and the under-bidder will be contacted and offered the opportunity to purchase the season.
